CMM controller cabinet introduction

Renishaw's CMM controller cabinet provides a solution for mounting Renishaw's range of CMM controllers, servo power amplifiers and interfaces, along with any compatible third party equipment. The cabinet uses standard 19 inch wide rack mounts.

Mains power distribution within the cabinet is controlled by a lockable isolation switch on the front of the cabinet.



Dimensions



The cabinet has a 12-way IEC distribution panel which supplies power to control and ancillary equipment.

Lifting

This denotes the lifting points on the cabinet:



NOTE: Lifting must only be carried out by the cabinet installer. Please contact the cabinet installer.

The CMM controller cabinet is lifted using the four eye bolts supplied.



Unscrew the four bolts securing the cabinet lid and remove.

Secure the four eye bolts in place in the holes labelled lifting points.

Use suitable slings as shown below.



WARNING: Specified cabinet weight is 65 kg with no control equipment installed. Please make provision for the weight of any equipment that is installed in the cabinet.

Following lifting, remove eye bolts and store within the controller cabinet. Keep eye bolts together using a cable tie or similar.

Replace the lid and bolt back in place ensuring the gasket washers are installed on each bolt.



CMM controller cabinet description

Isolation and control

The 12-way distribution panel has a lockable isolation switch that can be used to isolate the controller cabinet. Mains power isolation switch is located on the front of the cabinet. This switch removes power to internal IEC power outputs within the cabinet. The mains supply to the equipment is achieved via a IEC mains inlet connector.

<u>/</u>

The location of the mains power supply must be identified so it is clear and accessible to the operator how to remove power from the cabinet. This can be either at the mains plug on the wall or on any intermediate power supplementary power control equipment.



For maintenance to be carried out within the cabinet, the isolator switch should be turned off and power should also be removed from the mains plug or the supplementary power control equipment.



The cabinet must be located so users are able to easily access the power isolation switch.



The mains isolation switch on the wall or within supplementary power control equipment must be suitably labelled to identify its use.




The cabinet must be located to allow suitable ventilation to the fans.

For non-standard equipment configurations the equipment installed within the cabinet must provide its own fire enclosure.

Mains input connector

The cord used for connection to the mains must be rated to the minimum of supply specification detailed in 'Product specification'.

IEC C13 10 amp power connector.


Protective earthing

This equipment must be connected to a protective earth contact incorporating a protective earth conductor via a three core mains cable. This should not be negated by the use of an extension cable without a protective conductor.

Installation options


The cabinet must be restrained from toppling.

The preferred option is to use floor mounting fixings to secure the cabinet to the floor. The kick plates supplied in the cabinet kit should be secured to the floor. Pull force on floor fixing must be a minimum of 1 KN.

If cabinet cannot be fixed to the floor using kick plates then the suitable restraints should be used to remove the risk of the cabinet toppling.

Attaching bulkhead to cabinet

The bulkhead can be attached using the 4 × fitting screws supplied.



Tighten the screws using a 4 mm hex wrench to a maximum torque of 2 Nm.



Kick plate installation overview


Positioning holes for ground fixing

The cabinet should be fixed to the ground as part of the installation. The diagram below shows the location of the required holes to allow the use of floor studs.



The type and size of studs used is dependent on the requirements of the installation site. These details should be discussed prior to installation.


- 1. Fix the left-hand side plate to the floor using anchors.
- 2. Roll the cabinet into position.

3. Fix the right-hand side plate to the floor using anchors.




4. Fix the cabinet base to the side plates.

5. Once attached, fix the front and rear panels in place.





NOTE: If desired the cabinet can be re-positioned and re-installed by a single engineer with no lifting equipment. Please contact the installer to arrange reposition of the cabinet if required.



CMM controller cabinet maintenance

Authorised personnel service and maintenance



NOTE: There is hazardous live 240 Vac present within the cabinet.

CAUTION: Ensure that mains is fully isolated before any service or maintenance operations are carried out.

CAUTION: Following any service and maintenance an inspection of the mains wiring and protective bonding should be carried followed by a PAT test.

Periodic checks

It is advised to periodically check the cabinet and cable management system for damage or wear to key parts. Any visible damage or wear should be reported to the system maintenance engineer.

User serviceable parts

The cabinet has two fans which are the only user serviceable components.

Cooling fans




CAUTION: Ensure the cabinet is switched OFF before changing the filter.

The two cabinet fans are used to push air out of the cabinet for cooling the equipment within. One is located on each lower side panel.

The fans have mesh filters. Renishaw recommends that these are changed at least every 12 months. If the kiosk is located in an environment with high levels of particulates in the air, the filters should be changed at more regular intervals.

These filters should only be ordered from Renishaw.

Cleaning

The CMM controller cabinet should be cleaned with a dry, lint-free cloth.
